**Sub: Non-Applicability of Corporate Governance Report under Regulation 27(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for the Quarter ended 30<sup>th</sup> June, 2024**

With reference to the captioned subject we would like to inform you that, as per the Regulation 15(2) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI (LODR)) compliance with the Corporate Governance provisions as specified in Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of regulation 46 and para C, D and E of Schedule V shall not apply in respect of the listed entity having paid up Equity Share Capital not exceeding Rupees Ten Crores and Net Worth not exceeding Rupees Twenty Five Crores, as on the last day of the previous financial year.

The Paid up Equity Share Capital of the Company is Rs. 745.28 Lakhs i.e. below Rs. 10 Crores and Net Worth of the Company is -127.29 Lakhs i.e. below Rs. 25 Crores, as on 31.03.2024.

Therefore, Regulation 27(2) as per Clause 15 of Chapter IV of SEBI (LODR) Regulations, 2015 is not applicable to the Company for the quarter ended 30<sup>th</sup> June, 2024.

Whenever this Regulation becomes applicable to the Company at a later date, we will comply with the requirements of those Regulations within six months from the date on which the provisions become applicable to the Company.

Further, as per the query raised by BSE Ltd on 16<sup>th</sup> July, 2024 the Company is re-submitting the non-applicability certificate to the effect, duly signed by the Compliance Officer accompanied by a certificate from a Practising Company Secretary confirming the net worth of the Company for the previous three financial years.
